Purpose

Every two years, law enforcement officers representing their state, province or nation's Torch Run program, comprise a "Final Leg Team" which carries the "Flame of Hope" to the Opening Ceremonies of the Special Olympics World Games. In addition there is a final leg for Special Olympics USA Games held every four years.

Selection

Nominations/Applications may be submitted by an individual, a law enforcement agency or a Special Olympics program. All nominations should include a completed nomination form (1 page). All nominees will be presented to the Wyoming Law Enforcement Torch Run Executive Council for consideration.

The Torch Run Director shall appoint three council members to create a selection committee. It will be the recommendation of this committee that will be put forth to the council for a final confirmation. A nominee who is a member of the council will be recused from the discussion.

Criteria

The nominee's involvement must demonstrate a sustained and noteworthy contribution to the achievement of the goals of the Law Enforcement Torch Run. The minimum requirements to be nominated to represent Wyoming in a Final Leg are at least two years of participation in the Torch Run, achievement in program development, organization and fundraising success. Consideration will be given in the selection to assure there is a rotation in representation from the different regions of the state.
